Confirmation for Regulation (EC) 1907/2006 of the European Parliament, "**Registration**, **Evaluation**, and **Authorization of Chemicals (REACH)**, as interpreted by EU Court of Justice decision C-106/14 of 10 September 2015.

To Whom it may concern,

With reference to the EU REACH Legislation Regulations, EU RoHs Directive, etc.), and to the updated list of substances SVHC (substances of very high concern) (209) as published by ECHA. Mencom produces electrical and electromechanical, non-chemical products. As a manufacturer of these products, and in terms of REACH (1907/2006/EC), Mencom is considered a "downstream" user. As a downstream user, we not subjected to mandatory registration, nor obliged to compile safety data sheets. Mencom products purchased and used under normal conditions ought not to release substances on the SVHC list.

We confirm that our products do not contain residual hazardous substances originating from our production process. Regarding the current SVHC list (209 substances) we can, with the exception of lead (CAS no 7439-92-1) confirm that none of the candidate substances published until now- for which authorization / notification in necessary – is present within our products in concentrations above 0.1% weight by weight.

This finding is based upon the information retrieved by our suppliers of "preparations" and components involved in our products and the related products process – where applicable.

Based upon our present knowledge, we therefore confirm that none of our products is likely to be recalled or dismissed due to the REACH regulations.

If this should change in the future, we will provide information in accordance with our obligation under article 33 of REACH regulations.
